NOTICE REGARDING RESCHEDULING OF INTERVIEW MISCELLANEOUS SERVICES RECRUITMENT EXAM, 2018 (ADVT NO. 29/2017)

In view of the unprecedented surge in the number of COVID-19 cases in the State, the Commission has started taking the interviews for MISCELLANEOUS SERVICES RECRUITMENT EXAM., 2018(ADVT NO. 29/2017) in **online** mode with effect from 05 May 2021.

Some candidates have requested the Commission to reschedule their interviews for various reasons, including inter alia, pre occupation with Assembly Elections, Physical indisposition etc. The Commission has scrutinized the applications on a case to case basis. and after careful consideration of all the aspects involved, agreed to reschedule the interviews of the 40 (forty) candidates named at Annexure-A, in **online mode**, on the 1st June 2021, in 2 Interview Boards, subject to observance of the procedure indicated below.

A. The tentative time slot for the interview would be as follows:

The candidate will have to attend the **Online** meeting from any suitable location by accessing a link sent to the email id as per our record not more than 1 hour before the time scheduled for commencement of interview using a computer with webcam/Smartphone/tablet and high speed internet connection capable of supporting video conference.
- C. The candidate should remain present in front of the computer at least 30 (thirty) minutes ahead of the scheduled time of interview and remain present there until the interview is completed.
- D. The room should be well illuminated and no person other than the candidate should remain present in the room where the computer terminal is placed during the interview.
- E. The Mobile of the candidate (unless it is used for VC) should remain active during the entire duration of the interview so that calls can be made to the candidate, if necessary. The Mobile should, however, remain in silent mode to avoid interference with the interview.
