Sealed Quotations are hereby invited for **refilling of various cartridges of LaserJet Printer** (i.e. H.P. 88A, H.P. 12A, H.P. 35A , H.P. 80A &18A, Canon337, Brother TN B021 etc.) are hereby invited from registered bonafide and resourceful agency/ firms having from recognized bonafide, resourceful and reputed companies / suppliers / agencies (referred to as bidders) for use in office of P.S.C., W.B. at 161-A, S.P. Mukherjee Road, Kolkata – 700 026. The closing date of submission of the bids/quotations is the 14/11/2022 upto 3.00p.m. The bids/Quotations so submitted will be opened on the same day i.e. the 14/11/2022 at 3.30p.m. Quotations must include the cost of charges of refilling and replacement of Dram, Blade (Dr. Blade & Master Blade), P.C.R., Meg. Roller etc. of the above mentioned Cartridges + G.S.T. as applicable. Cartridges have to be refilled in full (100%). After refilling, the defective cartridges will have to be replaced and no charges will be paid in this respect.
