SCOPE OF WORK:

The job of Pest control shall include the following:

(i) Total area to be treated - Inside area of the entire building, i.e. Basement and G+9 floors (approx-85000 sq.ft)

(ii) General Pest Control/Anti Termite which means eradication of Cockroaches, Mosquitoes, Flies, Lizards, Termite etc through permitted insecticides as per Government of India and WHO norms. The Pest control should cover all the places like spray under the tables, chairs, almirahs, on and around the pile of files, on wooden furniture, on false ceiling, on all staircases, on lift lobby, on all toilets drain ducts, on all pantry rooms, in all stores and any hidden space under the furniture and should leave no space unattended.
