## **Instruction for Bidders**

- 1. The intending bidders have to complete videography of each candidate for a brief duration (2-3 minutes) as instructed by the Instructor in –charge of each trade.
- 2. Intending bidders have to arrange for cameras considering number of candidates in each session covering a maximum number of <u>25 candidates</u> in each phase for any particular trade spanning <u>45 minutes to 1 hour</u> to be decided by the instructor in-charge of each trade.
- 3. Intending bidders have to arrange manpower, instruments etc. required for videography of each candidate of each trade.
- 4. Intending bidders, while quoting their bids should include transportation charges and other logistic expenses to be provided to the videography team.
- 5. Intending bidders are advised to pay visit to the designated location on 28.06.24 in between 1:30 p.m to 4 p.m. to ascertain the location of different laboratories/workshops where the practical tests are scheduled to be held, places for battery charging if required etc.

## **Terms and Conditions:**

The intending bidders who are willing to comply with the following terms and conditions should quote rate:

- a) The rate of item of the above quotation shall remain valid for a period of 6 (six) months from the date of opening of the quotation.
- b) Intending bidder has to submit quotation with the photocopies of the latest and valid professional tax certificate, trade license, PAN card, valid 15 digit goods and services taxpayer identification number (GSTIN)
- c) The authority reserves the right to reject any or all quotations without assigning any reason whatsoever. The authority also has the right to extend the period of submission of quotation, by issuance of notice through office Notice Board/website, if the circumstance so warrants.
- d) Intending bidders should submit quotation during the office hours of the above mentioned time period at the earmarked box to be kept at the corridor of 8<sup>th</sup> floor in front of the chamber of the Accounts Officer of the Commission.
- e) Intending bidders have to arrange for hard disc drive (HDD) of appropriate capacity to capture videography of each candidate. They have to handover HDD to the PSC officials after completion of practical test. For the purpose, the bidders shall have to arrange to capture and transfer related files, tradewise and performance wise to HDD for easy identification of candidates.
