- 1) Candidates are requested to download Call Letter and Choice Sheet from Commission's Website at <https://psc.wb.gov.in> on and from **10-03-2025**. Number of vacancies in different services/posts are available at the Commission's Website.
- 2) The candidates are being called for Interview provisionally subject to verification of their eligibility and suitability for the examination in all respects including verification of original documents (e.g. academic qualifications, proof of age, BC/SC/ST/PH certificate/ NCL Certificate etc.).

- 3) If any candidate fails to produce any of the required original certificate(s) for verification before the Interview they will not be interviewed by the Commission and his/her candidature will be liable to be cancelled by the Commission straightway.
- 4) If any candidate does not appear at the Interview on the scheduled date and time, his/her candidature will be cancelled by the Commission straightway.
- 5) Ability to read, write and speak in Bengali [(not required for those candidates whose mother tongue is Nepali)-vide Finance Department Notification no. 1243-F(P) dated 02.03.2016] will be an essential qualification for this examination as per West Bengal Services (Compulsory Requirement of Knowledge in Bengali for Recruitment to any Post or Service) Rules, 2002.
- 6) No relaxation is applicable to S.C./S.T./O.B.C. candidates of other States as they shall be treated as general candidates
- 7) No claim for being S.C./S.T./O.B.C. (Non-creamy Layer) or a person with disability will be entertained after closing date of online submission of the application. In case of O.B.C. candidates, benefits of reservation of vacancies are admissible to O.B.C - Non Creamy Layer (Two Non-creamy layer certificates as mentioned in the Annexure-I, are required for this purpose) candidates of West Bengal only.
- 8) If at any stage even after issue of the letter of appointment, a candidate is found ineligible in terms of Advertisement his/her candidature will be cancelled without further reference to him/her.
