In view of the unprecedented surge in the number of COVID-19 cases in the State, it has been decided that interview for Agricultural Marketing Officer (Training & Canning) under West Bengal Junior Agricultural Service (Marketing) under the Department of Agricultural Marketing, Govt. of W.B. (Advt. No. 14/2019)-scheduled on 17^{th} May 2021 and 18^{th} May, 2021 will be taken in **online** mode. The date-wise schedule of interviews indicating Roll Number, Name and Category of the candidates is already available in the website.

- B. The candidate will have to attend the **Online** meeting from any suitable location by accessing a link sent to the email id as per our record not more than 30 minutes before the time scheduled for commencement of interview using a computer with webcam/Smartphone/tablet and high speed internet connection capable of supporting video conference.
- C. The candidate should remain present in front of the computer at least 30 (thirty) minutes ahead of the scheduled time of interview and remain present there until the interview is completed.
- D. The room should be well illuminated and no person other than the candidate should remain present in the room where the computer terminal is placed during the interview.
- E. The Mobile of the candidate (unless it is used for VC) should remain active during the entire duration of the interview so that calls can be made to the candidate, if necessary. The Mobile should, however, remain in silent mode to avoid interference with the interview.

 - (iii) Certificate/Marksheet of Madhyamik, Higher Secondary and "Degree in Food Technology/Food Technology and Biochemical engineering or equivalent" or "B.Sc. degree from a recognised University/Institute" and "Certificate of Training in Fruit Preservation/Fruit Processing at Central Food Technological Research

Institute, Mysore/Bangalore or any other Government or Government Organized Institution or five years' experience in a Fruit Preservation or Processing Factory of repute or Training Centre under Government.

- (iv) SC/ST/OBC certificate, if applicable.
- (v) Current 'NCL' certificate (for OBC candidates only).
- (vi) PWD certificate, if applicable.
