6. Current 'NCL' certificate (for OBC candidates only). NCL certificate should be issued not earlier **than 1st April 2022.**
7. Certificates as per the advertisement confirming Meritorious Sports Persons, if any.
8. PWD certificate, if applicable.
9. All the documents mentioned above will have to be produced before a Group-A Govt. Officer. Then a certificate in the format prescribed at '**Annexure-C**' will have to be obtained from the officer and have to upload it.
