### WEST BENGAL CIVIL SERVICE (EXECUTIVE) etc. EXAMINATION, 2023

### ADDENDUM TO ADVERTISEMENT No.- 01/2023

The Public Service Commission, West Bengal had issued the Advertisement for the West Bengal Civil Service (Exe.) etc. Examination, 2023 (Advt. No. 01/2023) on 25.02.2023. However, there was no provision for Economically Weaker Section (EWS) Category in the said advertisement. The Labour Department, Government of West Bengal had meanwhile issued Notification No. 18–Emp(EC)/LABR – 27011 (20)/01/2020 – EC dated 07.02.2023 whereby 10% reservation for the Economically Weaker Section (EWS) has been incorporated in the "Model 100 Point Roster of Vacancies" as notified by Labour Department vide Notification No. 50–EMP/1M- 25/98 dated 01.03.2011.

In the circumstances, the Commission incorporates the following points into its earlier Advertisement (Advt. No. : 01/2023) for the West Bengal Civil Service (Exe.) etc. Examination, 2023 through this Addendum to Advertisement No. : 01/2023. All other conditions mentioned in the original Advertisement remain unaltered.

RESERVATION:	Certain vacancies may be reserved for candidates belonging to Economically Weaker Section (EWS) of West Bengal.
	N.B.: Reservation of vacancies will be made as reported by the Government.

# PARTICULARS AND CERTIFICATES REQUIRED FOR EWS CANDIDATES:

- A candidate claiming to be EWS must have a certificate in support of his / her claim from a competent authority of West Bengal issued on or before 31.12.2023 and no claim in this regard will be entertained afterwards. In case a candidate is unable to produce the relevant valid certificate in support of the declaration/claim made by the candidate at the time of document verification, his/her candidature will be summarily rejected.
- 2. The benefit of reservation under EWS can be availed upon production of an Income & Asset Certificate issued by any of the following authorities in prescribed format as given in 'Annexure C'.
  - (i) In the District, Additional District Magistrate in charge of development matters of the District Concerned.
  - (ii) District Welfare Officer, Kolkata and Ex-Officio Joint Director, BCW&TD in respect of Kolkata for Kolkata Municipal Corporation Area.
     [in terms of PAR Department Memorandum No. 325 PAR (AR)/3P 1/2019 dated 09.07.2019, read with BCW Department Memo No. 959-BCW/MR-52/2019 dated 18.05.2023.]

\*However, any EWS Certificate issued in favour of a candidate by the erstwhile authorities as mentioned vide said P & AR Deptt. Notification will also be allowed if found valid.

**N.B:** EWS candidates must submit their renewed/revalidated certificates regarding EWS status prior to interview and at the time of appointment

#### **IMPORTANT INSTRUCTION**

Eligible candidates who have already applied for the examination and possessing valid 'Annexure C' may update their data in this regard through the link provided in the Commission's website (<a href="https://wbpsc.gov.in">https://wbpsc.gov.in</a>) which shall be available from 11.10.2023 to 31.12.2023. Such EWS candidates are required to take print out of their updated information and keep a copy of the same for future reference. This Addendum applies exclusively to EWS candidates only who have already applied for the examination earlier.
