Important Information regarding online document verification

The following documents will have to be scanned (Colour), then convert those into a **single PDF** file and send the PDF file to Email address :- dsconfidentialpsc@gmail.com

- 1) Recent passport sized coloured photograph.
- 2) Govt. photo identity proof (Aadhaar /EPIC /Passport/Driving Licence/PAN Card).
- 3) Madhyamik or equivalent Admit Card and Certificate (as evidence of age).
- 4) Certificates and Mark-Sheets of the Law Degree Examination.
- 5) SC/ST/OBC Certificate from appropriate authority, if applicable.
- 6) Two NCL certificates, which should be issued (i) within 01.04.2022 to 31.03.2023 and (ii) on and after 01.04.2023. (Applicable only in case of candidates belonging to OBC-A/OBC-B category)
- 7) PWBD certificate from competent Authority, if applicable.
- 8) As per clause 49 of the Advocates Act, 1961 "an advocate shall not be a full time salaried employee of any person, Government, firm, corporation or concern, so long as he continues to practise and shall, on taking up any such employment, intimate the fact to the Bar Council on whose roll his name appears and shall thereupon cease to practise as an advocate so long as he continues in such employment".

"The 'employment' spoken of by rule 49 does not cover the employment of an advocate who had been solely or in any case predominantly employed to act and/or plead on behalf of his client in Courts of Law". [Dipak Agarwal – Vs – Keshab Koushik (2013) 5SCC277]

Therefore, **Certificate of Enrolment as an advocate in the roll of Bar Council of any State or Union Territory in India on the date of advertisement for the examination is required. In case of Honorarium payee, a letter from his / her employment authority is required.**

- 9) Affidavit regarding any type of correction of discrepancy in Certificates.
- 10) All the documents mentioned above will have to be produced before a Group-A Govt. officer and a certificate in the format prescribed at '**Annexure - I**' will have to be obtained from the officer. **The original is to be submitted on the day of Personality Test. Scanned copy of this Annexure-I is also to be sent along with the other documents in a single PDF FILE.**


- **Certificates mentioned at points 4, 5, 7 & 8 must be issued on and before the closing date of online submission of Application (i.e. 31.01.2023)**
- Candidates are allowed to send the PDF file between **22.03.2024 to 02.04.2024.**
- File Name of the PDF file must be like this: **ROLL NO@WBJS2022PT.**
(e.g. 1234567@ WBJS2022PT)
- After online verification of all necessary documents furnished by all candidates, only eligible candidates will be called to Personality Test. The date and time of Personality Test will be announced later on.
